Cygnet Select Blue Lake and Pond Dye

Cygnet Select is a water dye for use in golf course water hazards, lakes, ponds, decorative water features and impounded bodies of water with limited outflow. Cygnet Select improves the appearance of surface water by turning waters a bright blue or blue-green color.

DIRECTIONS FOR USE

Use Rubber Gloves to Avoid Staining of Hands

- 1. Determine water volume (acre-feet) as follows: <u>Length (ft.) × Width (ft.) × Average Depth (ft.)</u> <u>43,560 sq. ft.</u> = Acre - feet
- Apply 0.25 gal. Cygnet Select per acre-foot of water as determined in #1 above. Acre-feet x 0.25 gal.= Gal. Cygnet Select Required.
- Cygnet Select may be poured directly into the water at several locations or into streams in recirculating systems to enhance dispersion.
- 4. Additional Cygnet Select may be added, as necessary, to maintain desired coloration.

PRECAUTIONARY STATEMENTS

CAUTION: Contains Acid Blue 9 Dye. Concentrated product may cause eye or skin irritation. Do not get in eyes, on skin or on clothing. Wear safety glasses or goggles and rubber gloves when handling. Do not taste or swallow. Wash hands thoroughly with soap and water after use. Remove and wash contaminated clothing before reuse. Do not mix with any other chemical. Concentrated product can stain fabric and other porous surfaces.

FIRST AID
